SPECIFICATIONS: The following specifications are intended to describe an inflatable swift water rescue boat for the Frame VFD and the details contained in these specifications are not designed to exclude any vendor from bidding, but are offered as a means of describing the needs of the Frame VFD. Where brand names may be used, the words "or equal" are assumed to follow. All specifications are minimum requirements.

Specifications for an Inflatable Swift Water Rescue Boat and Outboard Motor for the Frame Volunteer Fire Department, Inc.

The Frame Volunteer Fire Department is seeking to solicit competitive bids for the purchase of an inflatable boat and outboard motor suitable for rescue situations in a swift water environment. The following are required provisions for the watercraft and motor.

- The boat size shall be 11'-0" to 13'-0" long, 6'-8" to 7'-4" wide, not to exceed 220 lbs. in weight (w/o 1.) motor and fuel tank).
- The boat shall be an open-bow design, with two 24" side pontoons. Pontoon material shall consist of 2.) 30 oz./sg. yd., Mil-C-17415, type 9A material. The boat shall employ an inflatable floor with a selfbailing design. The transom shall be a minimum of one inch thick laminated plywood covered with boat fabric, clad fore and aft with CRES aluminum. A plywood thrust board is to be sealed into the floor and attached to the transom with aluminum legs to transmit power throughout the boat. After assembly, the completed product shall be vulcanized to produce an integral product.
- 3.) The boat shall not have less than five separate air chambers, each utilizing an overpressure relief valve.
- The designed working load shall not be less than 1500 lbs. and maximum buoyancy shall not be less 4.) than 4200 lbs.
- 5.) The maximum power rating for the boat must be 30 hp. minimum.
- 6.) The boat floor shall have no less than four foot anchors and d-rings for misc. anchoring. The boat must also have a minimum of six (three each side) carrying handles.
- The boat shall have the fire department's specified identifications vulcanized onto the side of the boat. 7.)
- The outboard motor shall be a 30 hp. electronic fuel injection four stroke motor with manual starting, 8.) tiller controls, gas assist trim, 20" shaft length and capable of utilizing 87 octane fuel containing up to 10% ethanol. A remote fuel tank with no less than a five gallon capacity shall also be provided.

TERMS & CONDITIONS:
