

**MINUTES OF THE PUBLIC TEST AND INSPECTION CONDUCTED BY THE COUNTY COMMISSION OF KANAWHA COUNTY, WEST VIRGINIA, HELD AT THE VOTER REGISTRATION OFFICE LOCATED AT 415 QUARRIER STREET, CHARLESTON, WEST VIRGINIA ON THE 22ND DAY OF APRIL, 2011 FOR THE MAY 14, 2011 PRIMARY GUBERNATORIAL ELECTION.**

The County Commission of Kanawha County, West Virginia convened at 8:00 a.m. on April 22, 2011 at the Voter Registration Office located at 415 Quarrier Street, Charleston, West Virginia for the Public Test and Inspection for the May 14, 2011 Primary Gubernatorial Election.

Present were W. Kent Carper, President, Dave Hardy, Commissioner, Jennifer Sayre, County Manager, Vera McCormick, County Clerk, Gerald Drucker, County Clerk (Record Room), Pat Fisher, Registrar, Patty Kirk, Mark Dawson, and Rodney Coles, Voter Registration..




The County Commission began the Public Inspection at 8:06 a.m. All 16 PC Memory Cards, containing 153 of the 160 precincts, were tested. Mrs. McCormick stated only 153 precincts were tested because there is a shortage of test ballots. A total of 291 ballots were scanned through the M100s, 138 Democratic Party Ballots and 153 Republican Party Ballots. The County Clerk and the Commissioners verified that the test was run and correctly tabulated. The County Clerk verified the over-vote, under-vote, and no-vote ballots were included as part of the test. Commissioner Hardy moved to deviate from normal security procedure. It was determined that out of necessity and from the recommendation of the County Clerk, the data test deck be placed in a strong box and secured. The previous procedure was to lock the information in the tabulating room, but this is impossible at this time because the room will be needed to process municipal election materials, the first being at 10 a.m. this morning for the City of South Charleston's canvass. Commissioner Carper verified this will not compromise the ballot in any way. Commissioner Carper seconded. Motion carried.

Commissioner Hardy moved to recess at 8:32 a.m. from the Public Test in order to convene for a scheduled special commission meeting. Commissioner Carper seconded. Motion carried. Back on record for the Public Test at 8:38 a.m.

The County Clerk verified the M100 machines were cleared of all test data and the tabulating machine was secured. Commissioner Hardy moved to approve the results of the Public Test and Inspection. Commissioner Carper seconded. Motion carried. Commissioner Hardy moved to adjourn from the Public Test and Inspection. Commissioner Carper seconded. Motion carried. Commissioner Carper remained present to secure the data cards in the strong box. The test data was secured at 9:04 a.m. and will remain locked and placed in a secure location until necessary to open On May 6<sup>th</sup> for the next test. At 9:10 a.m. Commissioner Carper and the County Clerk secured the door to the M100s.





